Work on the Clean Air Promise Begins

The League of Women Voters of Ohio Education Fund (LWVOEF), in partnership with local Leagues and with support from the national League of Women Voters Education Fund, is working to change the debate over the Clean Air Act from a focus on the cost of regulation to a focus on the public health cost of bad air quality. The campaign seeks to elicit the following promise from politicians, community leaders, League members and the general public:

"I promise to protect America's children and families from dangerous air pollution. Because toxics and pollutants such as mercury, smog, carbon, and soot, cause thousands of hospital visits, asthma attacks, and even deaths, I will support clean air policies and other protections that scientists and public health experts have recommended to the EPA to safeguard our air quality."

With grant support from the national League, LWVOEF is providing pass-through funding to participating local Leagues for activities that engage community leaders, politicians and the general public in their communities to make the promise to support clean air. Depending on the degree of involvement, local Leagues have the opportunity to earn between \$150 and \$400. In addition, LWVOEF has an intern, Munia Mostafa, who is dedicated to assisting local Leagues who want to participate in this important project.

Redistricting Reform Heats Up ****Op Ed Template Included****

Just when you think you know what is going on with redistricting, things change! In late September, the Apportionment Board adopted district lines for the Ohio House and Senate seats. Those maps are not being challenged even though they are designed to cause an overrepresentation of one political party (this time it is the Republicans) and deprive voters of an effective choice in general elections by intentionally drawing districts that are not balanced between Democrats and Republicans.

The current challenge is to the even more egregious gerrymander of Ohio's Congressional districts. Ohioans are about evenly split in their political leanings. However, Republicans are heavily favored in 10 of the 16 new districts, and mildly favored in two more. Democrats are heavily favored in four districts.

The Congressional districts are approved by the General Assembly just like any other piece of legislation and they are subject to referendum just like any other piece of legislation. One exception is an appropriations bill – those become effective immediately. Last week the Ohio Supreme Court decided that adding money to the redistricting legislation didn't make it an appropriations bill – so it can be sent to the voters for their approval or disapproval just like any other legislation (like the referendum of SB 5 which is on the ballot this year).

If enough signatures are gathered, the referendum would be on the November 2012 ballot – but that is when we need to elect our new Congressional delegation – so we need districts before that. Ideally, the legislature will come to a bi-partisan compromise that also considers the criteria we used in the map-drawing competition this year.

The League is remaining focused on the long term. What is really needed is a new way of drawing the districts so this chaos is not repeated again in 10 years.

Election Questionnaire and Interviews of Boards of Elections

The state League is asking for your help in assessing how well the election went. LWVOEF has developed a simple survey that we hope you will ask your members to complete and return to the state League. (click [here](#) to read the survey) This will be, of course, an unofficial sampling, but we hope it will give us some insight into what is happening on the ground on election day and the weeks leading up to the election. We will be contacting League presidents with more details about how to participate in the survey.

In a more formal fashion, as we did in 2009, we will be inviting local Leagues -to interview their board of elections post-election as part of the lawsuit monitoring process. Twenty-two Leagues participated in the interviews two years ago –and your state League garnered important information regarding compliance with the lawsuit settlement agreement. Virtually all who participated found it an excellent tool to build relations with their local boards. The results were published in a report entitled “Off to a Good Start” (click [here](#) to read the report). We will be communicating further with detailed information about this important opportunity for your League in the next few weeks.

Some members have asked if the League will be doing audits after this election. The League will not be conducting an audit for this election because it is not required. Audits will be required after the primary election and the 2012 general election.

House Bill 194 Referendum Update

The petition drive (supported by the state and local Leagues) to collect signatures to repeal HB 194, the bill changing Ohio’s election law passed by the Ohio legislature earlier this year, has been successful. The coalition collecting signatures turned in nearly 100,000 more signatures than required. The signatures will be verified by boards of elections after the election. Assuming the count holds, HB 194 will not go into effect unless approved by the voters in the 2012 general election. This means that both the 2011 and 2012 elections will be governed by the previous law.
