Clean Air Promise Campaign Continues

If your League was unable to participate in the Clean Air Promise campaign earlier because of the many demands during election season, it is not too late to participate. Time to Interview Your Board of Elections

As we did in 2009, the LWV Ohio Education Fund is inviting local Leagues to interview their Board of Elections to learn about how the November election went. This is a very important aspect of our monitoring of the Secretary of State's compliance with the requirements of the 2009 settlement agreement in the League's historic lawsuit: *LWVO v. Brunner*. The second purpose is to strengthen relations between local Leagues and their Board of Elections. We hope that your League will choose to participate, as did 22 Leagues in 2009. Participating Leagues will receive a small remuneration of **\$50**.

A Redistricting Update for All Members

LWVO/EF is now hosting a monthly **conference call for all League members** to help keep you informed about what is happening at the Statehouse, supply you with tools and information to assist you in strengthening your local League, and provide an opportunity for information-sharing between local Leagues. **The calls are scheduled for the first Tuesday of every month at Noon.**

The December call will be on **redistricting -- Tuesday, December 6, at 12:00 p.m. - 1 p.m.** Join Ann Henkener, LWV Ohio redistricting specialist, as she brings us up to date on all the developments on redistricting and the extraordinary work the League is doing. House Bill 194 (HB 194) Referendum Update

Groups-including the state and local Leagues-seeking a referendum on HB 194, the election-law bill passed this summer, are about 10,000 signatures short of the required 231,150 verified voters' signatures-although the threshold for signatures per county has been met. Thanksgiving is the deadline to submit additional signatures, and according to the Democratic Party, an additional 150,000 signatures have already been collected.

If the required number of verified signatures is attained, HB 194 will not go into effect unless approved by the voters in the 2012 general election. This means that the 2012 election will be governed by the previous law, as was the November, 2011 election.

Human Trafficking Study: Opportunity for Local League Involvement

The Committee studying Human Trafficking is encouraging local Leagues to become involved in the study by assessing the awareness of human trafficking incidents in their own communities. This can be done through contacts with local law enforcement, area coalitions ([click here](#)) and service providers. Other sources might be the Salvation Army, Children Services, and Juvenile Court. We suggest gathering the following information:

1. Number of incidences: a. Sex trafficking; b. Labor trafficking
2. How a victim of trafficking is recognized ([Click here](#) to see the check list of general indicators used by Lucas County.)
3. What services do you see are needed in your area to aid victims?
 1. What agencies do you work with?
 2. What financial resources do they use?
 3. What financial resources do they need?

Is Your League Concerned about Fracking?

A number of Leagues have expressed concern about fracking in Ohio and have asked the State League how they might get involved. Board member Kristin Vessey has agreed to coordinate local Leagues' efforts and share information about developments in Ohio.
